CAMP McDOUGALL REPORT: John Porter

- ► Everything is on schedule for the summer.
- ► Treasury: good financial position, but most of money is spoke for.
- ➤ Six positions fully funded by Human Resources Development Canada; 8 positions applied for through Ministry of Northern Development & Mines for \$2 per hour.
- ➤ Staff hired: back to full complement...may be bit of a risk but necessary to have that many staff if we get the same number of campers as last year.
- ► Churches requested to promote camp in congregations due to poor economy and also provide as many sponsorships as possible. **Proposal:** That the Board communicate on the registration form that it costs \$400 per camper to send them to camp. Give options for

payment of \$400, \$300 and the regular \$250 in hopes that some will pay the higher amounts.

- ► The raising of Warren house will be completed in May.
- ► The Wolgemuth family has been contacted with a request to use their memorial to p0urchase a new stove.
- ► Camp is looking for chaplains this year to come from clergy due to the fact that children need these roles models in their upbringing.
- ► Terry Ainsley will upgrade the road into camp.
- ► The Board no longer will do pasta dinners for fundraising. They request that churches/charges take on this task.
- ▶ **Proposal:** Could churches/charges adopt a cabin and take care of maintenance and cleaning?

Accompaniment Program: The Ecumenical Accompaniment Program in Palestine and Israel (EAPPI) seeks to support local and international efforts to end the Israeli occupation and bring a resolution to the Israeli-Palestinian conflict with a just peace, based on international law and relevant United Nations resolutions.

United For Peace: The United for Peace Campaign, which will run from November 4, 2007, to December 2009, was approved at the 39th General Council 2006 out of grave concern for the situation in Israel and Palestine. The scope of the campaign has been broadened by the General Council Executive to also address violence and the need to work toward just peace in Canada and in other parts of the world.

Gambling

The United Church, with a long history of concern about gambling and gaming, has been persistently outspoken against its recent expansion,

and urges its members to avoid using funds generated from gambling activities. Traditional reasons for opposition to gambling include the following:

- It defines success materially, with very few "winners" succeeding at the expense of the vast majority of "losers." Building "the people" is replaced by competition among individuals.
- It goes against an equitable division of God's creation amongst God's people.
- It exploits the vulnerable in the community (problem gamblers and those affected by their behaviour) by vested interests.

The United Church is gravely concerned about recent changes:

- gambling is becoming more addictive and accessible
- gambling is controlled by large corporations instead of small businesses
- gambling has become a source of government revenue that replaces community taxation with gamblers' losses
- gambling is legitimized by being linked to charities.

Protecting the social safety net is our way of doing what the early followers of Jesus did in distributing basic goods for widows and orphans: it is a not a charity, but duty that should be shared by all taxpayers.
